From Your Grand Knight:

Frank Montelione

Well this will be short as I've been a bit preoccupied this past month. I really appreciate all the thoughts and prayers that have been made for Ruthie and me over the past weeks---thanks!!! I also want to thank the council for the outstanding work over the past year, the time flew by and I am excited about the upcoming year. This is one time that I don't think special thanks to any individual will do it, thanks goes to the whole council --- what a year!!! It has been an honor to serve as Grand Knight and again I am looking forward to the new fraternal year. Dale will be attending the Convention and we'll look to him for an update accordingly.

There are elections upcoming at the next meeting and the nominating committee recommended the following slate of officers (I've again included their duties so they are aware of the commitment they are making to this position):

Grand Knight Frank Montelione

The grand knight is responsible for the welfare of the council. He presides over council meetings, acts as an ex officio member of all committees, appoints a membership and programming director, convenes officers for a monthly meeting, and ensures all necessary reports are submitted to the state and Supreme Council. He should also be aware of the council's financial status and ensure that his signature appears on all checks drawn.

Chaplain

The chaplain is the spiritual advisor of the council. He is expected to make a report at council meetings on religious matters. The Grand Knight appoints a priest or a deacon in accordance with any rules established by the Bishop of the diocese to serve as council chaplain.

Deputy Grand Knight Dale R Saunders

The Deputy Grand Knight is second in command. He assists the Grand Knight with council affairs and fulfills all duties assigned to him by the Grand Knight. Should the Grand Knight be absent from a council meeting the Deputy Grand Knight will preside. He is chairman of the council's retention committee.

Chancellor Jeffrey L. Dallape

The chancellor has a variety of responsibilities. Primarily, he assists the Grand Knight and the Deputy Grand Knight in the execution of their duties and oversees the council in both their absences. He is charged with strengthening the members' interests in council activities. The chancellor is chairman of the admission committee.

Recorder Don Zinkiewicz

The recorder is similar to a court reporter or a secretary. He is responsible for maintaining a true record of all actions of the council and its correspondence. A Recorder's Minute Book is available from the KOC Supply Department for keeping a record of council meetings.

Financial Secretary George T. Adams

The financial secretary is appointed by the supreme knight, upon recommendation of the council. His main area of responsibilities is maintaining all financial and membership records. He collects and receives all moneys from all sources, including annual dues from council members. He also handles supply orders for the council officers and members, filing the Report of Officers, and submitting all membership transactions to the Supreme Council.

Treasurer James C. (Jim) Lawler

The treasurer is responsible for the safe keeping and maintaining records of all council funds and accounts. He is responsible for depositing money into the council's accounts and provides a certificate of such monies to the Grand Knight. He is also responsible for payment of all expenses.

Lecturer Ronald E. Stinton

The lecturer is appointed by the Grand Knight to provide both educational and entertaining programs to the council. He is responsible for the "Good of the Order" portion of council meetings. In order to provide members with informative and educational programs, he must be knowledgeable and aware of all council programming.

Advocate Michael H. (Mike) Perduto

The advocate is the legal representative of the council and serves as the council's attorney at trials and investigations of any interest to the council. While he does not need to be a member of the legal profession, he should be familiar with the council bylaws, the Order's Charter, Constitution and Laws, Methods of Conduction a Council Meeting and Robert's Rules of Order.

Warden Richard L. (Rick) Broderick

The warden is the 'watchdog' for the council property and degree paraphernalia, except the property of the financial secretary, treasurer and recorder. He is also responsible for setting up the council chambers for meetings and ceremonial work. During ceremonial exemplifications, he will appoint and supervise the guards.

Inside and Outside Guards Edward Baranowski and Tom Godel

The guards have similar responsibilities, but distinct differences. The outside guard tends to the outer door admitting visitors and members to the inner door. Once at the inner door, the inside guard checks to make sure that their membership cards are current.

Board of Trustees 3 Yr Trustee Bill Rothamel, 2 Yr Trustee Craig Russell, 1 Yr Trustee Jim Byars

The board of trustees consists of three members elected by the council and the grand knight, who serves as chairman of the board. They oversee the work of the financial secretary and treasurer, and with the deputy grand knight serve on the council's retention committee. During council elections, only the three-year trustee is voted on, with the others moving on to become two and one-year trustees, respectively.

Potpourri from the Deputy Grand Knight—May, 2006

Our recent KC Information evening resulted in six forms 100 from the eight people attending, with a seventh on the way. Add Frank's son who is transferring his membership along with another recent transfer and we will finish the year with an additional eight to ten members. Our District Deputy has advised a first degree will be scheduled June 6th to allow sufficient time to end the membership fraternal year on a real upswing! It's been a great year from a new member perspective, however we now need to make sure all these new brothers become as acclimated in the council as is possible.

Ed Baranowski recently proposed we activate a "calling tree" to keep all brothers better in the communications loop. At the May officers meeting **Mike Perduto 779-8214** volunteered to head this much needed effort/committee and would like to have **8-10 people assist** in the project. Only requisite needed is like to talk/visit with people on the telephone and be willing to be responsible for communicating with 8-12 brother council members each month. I've heard it said the council has tried this in the past and "it didn't work"! All of us who know Mike know he is serious about having this work and making this a successful membership communication tool. Enthusiastic, determined people will always make the difference between success and somewhat lesser results. Please **call Mike and volunteer** to be a part of this vital committee.

Remember our June 6th business meeting is the annual council officer election evening. Deacon Jim Seidel is scheduled to speak with us during the program portion to start at 7:30 PM, about upcoming Parish 'Outreach Projects' including a Homeless Issue he will be working to address in the upcoming year. It would be nice to provide a good audience for him as well as to possibly develop ideas where the Knights might provide better support to our Parish community.

A slate of proposed officers to be elected is located elsewhere in this newsletter. However since the floor is open for nominations, I am taking nothing for granted and would like everyone to know I would like to continue in my job and would appreciate your presence and support. Please show up and vote.

The first Tuesday of July is the 4th! Obviously we would not expect anyone would interrupt holiday firework plans for a KC meeting, so **A ONE TIME CHANGE TO JULY 11TH IS BEING MADE!** Please get this into your planning calendars now.

In lieu of a 3rd Tuesday officer/social meeting for July 18, we are scheduling a Council planning meeting on Saturday, July 15, 2006 to determine (with your help/input) our new plan of the year. It will be similar in format to the mid-year evaluation we conducted at Stewart's Bistro this winter and will involve several hours to discuss, review program activities for this year, and plan what we want to keep/revise for next year. This would be a good time to discuss any areas we need to improve upon or to talk about that "pet idea" you have been harboring that the Knights should be involved with. It is anticipated this would either be a **working breakfast meeting or a meeting that concludes with lunch.**

Ownership of this council's planning rests with each of us. Plan to attend and participate! Location and time will be announced by the June business meeting and be in the July newsletter also. We are close to being the most active council in our District, however there is still more we could do to make our church/parish community a better place to live/worship.
